

## **SOFTWARE End User License Agreement**

EULA stands for **End User Licensing Agreement**. This is the agreement through which the software is licensed to the software user.

**CYMATIC TRADER SOFTWARE** (which includes Advanced Cymatic Trader) is the software created by Cymatic Ltd including but not limited to the version commonly known as 'Advanced Cymatic Trader for Betfair' and is for use in trading and/or betting on the Betfair exchange and/or any other online betting exchange.

### **EULA**

**END-USER LICENSE AGREEMENT FOR CYMATIC TRADER SOFTWARE IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL:** End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and CYMATIC LTD. for the CYMATIC LTD software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and CYMATIC LTD, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the SOFTWARE PRODUCT.

The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold.

#### **1. GRANT OF LICENSE.**

The SOFTWARE PRODUCT is licensed as follows:

##### **(a) Installation and Use.**

CYMATIC LTD grants you the right to install and use copies of the SOFTWARE PRODUCT on your computer running a validly licensed copy of the operating system for which the SOFTWARE PRODUCT was designed [e.g., Windows 2000, Windows 2003, Windows Server 2008, Windows XP, Windows Vista, Windows 7].

##### **(b) Backup Copies.**

You may also make copies of the SOFTWARE PRODUCT as may be necessary for backup and archival purposes.

##### **(a) Maintenance of Copyright Notices.**
